### DECLARE

- 1) By signing this agreement, the participant acknowledges that the participation at Italy500miles is voluntary as it is strictly voluntary and optional every action performed during the conduct of the activity. He/She declares to be fully aware of the possible risks incurred while participating in the above-mentioned activity.
- 2) The participant acknowledges that Italy500mileds will be conducted on public roads and will be driven individually, according to the Italian Road regulations.
- 3) The participant acknowledges that the Organizing Committee (abbreviated as O.C. as from hereon) of Italy500miles has informed him/her that the O.C. has not undertaken any safety measures on the roads during the Italy500miles.
- 4) The O.C. Italy500miles only provides a road book, check point staff but **no road assistance** in case of motorcycle breakdown.
- 5) The participant acknowledges that the O.C. of Italy500miles has advised him/her to respect all traffic rules of the Italian Road Regulations and to constantly evaluate his/her ability to drive for long stretches of road.
- 6) The participant explicitly acknowledges not to file any claim with respect to O.C. Italy500miles, Parma Chapter Italy officers (American Bikes a.s.d.) and members, Harley-Davidson staff and all the personnel involved with the organization of Italy500miles.
- 7) The participant acknowledges to take all necessary measures in order to safeguard the O.C. Italy500miles's liability against any dispute that might arise or be brought before a court.
- 8) The participant authorizes the O.C. Italy500miles to publish, sell, distribute pictures or videos (with own image) taken during Italy500miles and personal data, by any lawful means and electronic supports such as CDs, DVDs, audio, visual, internet, etc.
- 9) The nullity of one of the above-mentioned points will not affect the validity of the others or the whole agreement.
- 10) As a result of the foregoing, the undersigned intends to discharge with this document, the organization, the association and its governing bodies, from liability in any way that may arise as a result of participation in the activity, for any damage suffered by themselves or caused to third parties in the conduct of the same.
